## Categories of data and their source

The Data Controller processes data of a common nature (name, surname, qualification, etc.), data of a particular nature (data relating to health, trade union membership, etc.) and/or data relating to criminal convictions, crimes and security measures: this information may be collected directly from the person to whom it refers (hereinafter "Interested Party") and/or from third parties (e.g. when the reporting party provides information on the reported person and/or other persons mentioned and/or the facilitator, or when additional information/documents are acquired in the course of the investigation from other structures of Vetroelite S.r.l.

## Purpose and legal basis

**A. Management of the report**: personal data are processed to manage the investigative activities aimed at verifying the merits of the reported fact and taking the consequent measures.

Rectification: you can request that your personal data be updated, corrected (if inaccurate), and incomplete data be supplemented.

**Deletion**: it is possible to obtain the deletion of your personal data when certain conditions are met (for more information contact the Owner).

**Limitation**: it is possible to request that data be flagged, so as to limit its processing in the future, if certain conditions are met (for more information contact the Owner).

Objection: you can object to the processing of your personal data, on grounds related to your particular situation, where the processing is based on legitimate interest or is necessary for the performance of a task of public interest or connected with the exercise of public authority vested in the Controller.

**Portability**: it is possible to receive in a structured format the personal data provided to the Controller and to transmit you to another controller if the processing is based on consent or contract and is carried out by automated means.

Withdrawal of consent: it is possible to withdraw consent for the purposes that required it, without prejudice to the lawfulness of the processing carried out up to that point.
